2. Grant - FY11 Fresh Fruit and Vegetable Program July 2010 - September 2010.

Authorized the State Superintendent of Schools to award a grant to 77 Georgia schools at a cost not to exceed \$687,300 in Federal Funds for the 2010-2011 Fresh Fruit and Vegetable Program.

3. Grant - FY11 Fresh Fruit and Vegetable Program October 2010 - June 2011.

Authorized the State Superintendent of Schools to award a grant to 77 Georgia Schools at a cost not to exceed \$2,061,900 in Federal Funds for the 2010-2011 Fresh Fruit and Vegetable Program.

4. Grant – Title I, Part A, 1003(a) RESA School Improvement Grants FY11.

Authorized the State Superintendent of Schools to award a grant to Regional Educational Service Agencies (RESAs) at a cost not to exceed \$3,835,000 in Federal Funds for school improvement services to Title I schools in Needs Improvement levels 1-3.

5. Grant – FY11 21st Century Community Learning Centers New Sub-Grantees.

Authorized the State Superintendent of Schools to award a grant to 27 new 21st Century Community Learning Center programs at a cost not to exceed \$9,137,823.00 in Federal Funds for non school hour programs.

6. Grant – FY11 Education for Homeless Children and Youth Grant Competition.

Authorized the State Superintendent of Schools to award a grant to 14 LEAs at a cost not to exceed \$562,745 in Federal Funds for McKinney-Vento grants for homeless children and youth.

7. Grant – FY11 Title I, Part A and Title I, Part A Neglected & Delinquent (N&D) Reserve, Formula Grants to LEAs; FY11 Title I, Part C Migrant Grants to LEAs; and FY11 Title I, Part D Subpart 2 Grants to LEAs. Authorized the State Superintendent of Schools to award a grant to local educational agencies (LEAs) at a cost not to exceed \$495,556,657 in Federal Funds to provide eligible LEAs with supplemental federal funds to ensure eligible children meet state academic achievement standards.

8. Grant – FY10 Rural and Low Income Schools Grant Award Amendment.

Authorized the State Superintendent of Schools to award amended grants to 87 LEAs at a cost not to exceed \$6,751,232 in Federal for Title VI, B Rural and Low Income Grants.

- 9. Grant Title II, Part A Highly Qualified Teachers and Improving Teacher Quality State Grants (ESEA) FY11. Authorized the State Superintendent of Schools to award a grant to Local Educational Agencies at a cost not to exceed \$76,513,778.00 in Federal Funds for the FY11 Title II, Part A Highly Qualified Teachers and Improving Teacher Quality State Grants.
- 10. Grant Amendment Title I, Part A, Section 1003(g) School Improvement Grants and Title I, Part A, Section 1003(g) ARRA School Improvement Grants Amended Allocations FY11. Authorized the State Superintendent of Schools to amend the grant allocation to local educational agencies to increase by \$10,245,976 for a new total grant not to exceed \$29,803,943 in federal funds to provide funding to LEAs to drastically improve their persistently lowest achieving schools and significantly raise student achievement in the identified schools.
- 11. <u>FY11 Grant Mathematics and Science Partnership (MSP) Program, Title II B.</u>
 Authorized the State Superintendent of Schools to reallocate grant funds to twenty-five Local Educational Agencies (LEAs) at a cost not to exceed \$1,244,702.00 in Federal Funds for the Title IIB Mathematics and Science Partnership Program.
- **12.** FY11 Contract Utah State University, Technical Assistance for Excellence in Special Education. Authorized the State Superintendent of Schools to enter into a contract with Utah State University, Technical Assistance for Excellence in Special Education, at a cost not to exceed \$95,000.00 in Federal Funds for the provision of Training and Assessment of Educational Interpreters.
- **13.** <u>FY11 Contract Kennesaw State University.</u> Authorized the State Superintendent of Schools to enter into a contract with Kennesaw State University at a cost not to exceed \$150,000.00 in State Funds for the activities and initiatives of the Georgia Youth Science and Technology Centers (GYSTCs).
- **14.** <u>FY11 Contract Columbus State University.</u> Authorized the State Superintendent of Schools to enter into a contract with Columbus State University at a cost not to exceed \$133,989.38 in Federal Funds for the development of the instructional framework for an astronomy course and the preparation of professional development for astronomy teachers.
- **15.** <u>FY11 Grant Math Mentor Funds to RESAs.</u> Authorized the State Superintendent of Schools to award a grant to 16 Regional Educational Service Agencies at a cost not to exceed \$1,787,328.00 in State Funds to fund 16 Math Mentor positions.
- 16. <u>FY11 Contract ACCESS for English Language Learners (ELL) Contract Renewal.</u> Authorized the State Superintendent of Schools to enter into a contract with the University of Wisconsin at a cost not to exceed \$1,932,000.00 in Federal Funds for services and products related to the printing, distribution, administration, scoring and reporting of the Assessing Comprehension and Communication in English State-to-State for English Language Learners (ACCESS for ELLs), the state-adopted English proficiency measure.
- **17.** <u>FY11 Contract Amendment Georgia Online Assessment System.</u> Authorized the State Superintendent of Schools to amend the contract with Riverside Publishing to increase by \$64,200.00 in other funds for a new total contract not to exceed \$972,372.00 for

- improvements of reporting structures within the Online Assessment System (OAS).
- **18.** <u>FY11 Contract Amendment End of Course Tests.</u> Authorized the State Superintendent of Schools to amend the contract with NCS Pearson to increase by \$190,000.00 for a new total contract not to exceed \$5,830,193.00 in Other Funds for the development of additional Mathematics I and II items for inclusion in the Online Assessment System (OAS).
- **19.** <u>FY11 Contract Battelle for Kids.</u> Authorized the State Superintendent of Schools to enter into a contract with Battelle for Kids at a cost not to exceed \$250,000.00 in Other Funds for services related to piloting the value added model proposed in Georgia's Race to the Top application with a small number of districts.
- **20.** FY11 Contract Amendment Teachers on Assignment for Mathematics and English Language Arts (ELA). Authorized the State Superintendent of Schools to amend the contract with the local school districts of Rockdale, Forsyth and Cherokee for \$3,354.98 for a new total contract not to exceed \$238,354.98 in State Funds.
- 21. FY11 Contract Criterion-Referenced Competency Tests Modified (CRCT-M).

 Authorized the State Superintendent of Schools to enter into a contract with The Board of Regents of the University System of Georgia at a cost not to exceed \$1,515,934.00 in Federal Funds for services related to the development, administration, printing, distribution, scoring, and reporting services of the Criterion-Referenced Competency Tests Modified (CRCT-M), an alternate assessment for students with disabilities.
- **22.** A Pilot for the Fitness Assessment Program. Authorized the State Superintendent of Schools to accept federal funds in the amount of \$125,200.00 from the Georgia Department of Community Health for a pilot fitness assessment program in school year 2010-2011.
- 23. Grant FY11 High School Program Grant Amendment for Career, Technical and Agricultural Education. Authorized the State Superintendent of Schools to amend the grant to the attached list of grantees by \$684,600.00 in State Funds at a total cost not to exceed \$41,072,723.00 for CTAE Career Technical Student Organization/Family, Career and Community Leaders of America (CTSO/FCCLA) High School Programs.
- **24.** Approval of the Membership on the State Advisory Panel for Special Education.

 Authorized the State Superintendent of Schools to approve the new member appointments to the State Advisory Panel (SAP) for Special Education.
- 25. Georgia Performance Standards for Fourth Year Mathematics Courses. Granted permission for the posting of the Georgia Performance Standards for Advanced Mathematical Decision Making (AMDM), Advanced Mathematical Decision Making in Industry and Government, and Advanced Mathematical Decision Making in Finance for public review and comment.
- **26.** Georgia Local School Board Governance Standards and Model Ethics Policy. Granted permission to post the Georgia Local School Board Standards and model ethics policy for Local School Board Governance for public review and comment.
