9:00 - 10:00	Welcome Panel Member Introductions and Update	Stephanie Moss opened the meeting and welcomed members. Panel members provided updates and announcements.
10:00 - 10:30	GaDOE, Divisions for Special Education Services and Supports Update	Kim Hartsell presented updates from the Division for Special Education Supports.
		She discussed the implementation of Positive Behavior Supports (PBS) in schools throughout Georgia.
		Ms. Hartsell reported that the Georgia Project for Assistive Technology (GPAT) has been selected by United Cerebral Palsy of Greater Chicago (UCP)/Infinitec to participate in a potential grant which will allow access to online modules and information systems related to assistive technology.
		The Georgia Instructional Materials Center (GIMC) has been working with the online program, Lexiflow, to create fully accessible digital versions of textbooks which can be downloaded from the internet. This project has been piloted in 3 systems this year and plans to roll out the program statewide next year.
		Georgia is developing a pilot special education teacher induction program to address the issue of teacher retention, providing support for special education teachers for up to 3 years.
		Debbie Gay provided an update regarding professional development opportunities available through the Division for Special Education Services.
		The second annual Autism Academy will provide training for professionals working with students with Autism this summer. This includes a continuation of training for teachers and staff who attended the first academy as well as a strand for

		individuals attending for the first time.
		A Make and Take workshop in being offered for teachers of students with significant disabilities to create materials aligned with the Georgia Performance Standards (GPS).
		Mrs. Gay reported that the Divisions for Special Education continue work with disproportionality issues in areas of discipline, over-identification and placement. The department is also looking at under-identification of students with disabilities and will be working with districts through a series of Elluminate sessions.
		A work group, including parent attorneys, parent mentors, and parents from around state, has been formed to develop a more easily understood version of the parent rights brochure.
		The Special Education website has been updated with information and resources on Dyslexia.
		Mrs. Gay summarized House Bill 907, which requires school districts to give notification to parents on SB10 twice a year and at each IEP mtg.
10:30 - 11:30	Panel Discussion: Special Education and LRE	Susan Brozovic presented on the department's Least Restrictive Environment Initiative and answered questions from the panel.
11:30 - 12:00	Public Comment Session	One person provided public comment on restraint and seclusion. Three public comment letters were presented by Stephanie Moss. Issues addressed included restraint and seclusion and Autism.

Local District least restrictive environment data will be considered in FY11 as districts are selected for Focus Monitoring.
