| 9:00 - 9:45 | Welcome Panel Member Introductions and Update | Radha Vettraino opened the meeting and welcomed members. Panel members provided updates and announcements. Dr. Lee Shiver, Director of the Georgia School for the Deaf, welcomed the panel to the school. |
| 9:45 - 10:45 | State Performance Plan/Annual Performance Report (SPP/APR) Overview | Elise Lynch and Zelphine Smith-Dixon presented an overview of the State Performance Plan, as well as the required changes for this year, and answered questions from panel members. The 3 priority areas set by the Office of Special Education (OSEP) which include Free and Appropriate Public Education (FAPE), General Supervision and Disproportionate Representation as a Result of Inappropriate Identification were reviewed. |
| | | The difference between the State Performance Plan (SPP) and the Annual Performance Report (APR) was reviewed. Georgia met requirements established by the Federal Government for FY 2009 APR. Staff discussed how each Local Educational Agency (LEA) is measured for meeting indicator requirements. Each indicator was discussed in detail, including what each indicator measures and the targets for that indicator, including upcoming targets. The status of each indicator was reviewed with the panel, including whether the target was met and, if not, whether progress was made towards meeting that target. |

| 11:00 - 11:30 | SPP/APR Small Group Activity | Panel members worked in small groups to make recommendations for the SPP/APR indicators.Panel members were separated into 5 groups and assigned a set of indicators. Each group was asked to review the 3 year trend data for their indicators, review the state proposals for extension and provide proposals for targets for each of the group's indicators. Each group reported on their recommendations at the end of the work period. |

The elements necessary for transition teams to have a successful transition process for students were discussed. These included when the initial transition plan should occur, who should be invited to be a part of the transition team, the transition form that IEP teams could use and the components that are required by the Department of Education for compliance. Mrs. Nations discussed the types of transition goals that are appropriate to show what a student will be doing after graduation as well as the |

| | | <u>Family Engagement</u> : The committee presented recommendations on additional topics to be added to the one page flyers already published. The committee also requested that a presentation on family engagement activities at the Department of Education be added to the docket this year. |
| | | Dispute Resolution: The committee reviewed topics that have resulted in complaints and looked at trend data from FY 2007 through 2011. The number of complaints has increased each year and current data for this year seems to be similar to the previous year. The number of mediation requests has decreased. Due process complaints have also decreased. |
| 10:00 - 10:30 | GaDOE, Divisions for Special Education Services and Supports Update | Debbie Gay presented updates from the Division for Special Education Supports and Services. Mrs. Gay discussed the launch of the Graduate First website (www.graduatefirst.org). The department is working to promote the website with special education and curriculum directors around the state. The website contains tools to assist districts such as data tools, webcasts, and tools for preventing dropout and increasing attendance. The Least Restrictive Environment (LRE), a new project designed to increase the amount of time students with disabilities spend in general education through providing coaching and improving environments was discussed. Kathy Everett is involved with the project along with Gail Wilkins. The project is being implemented in Cobb and Bibb Counties. A proposal was passed at the last state board meeting to remove the Georgia High School Graduation Test (GHSGT) and replace it with |
| | | Georgia High School Graduation Test (GHSGT) and replace it with End of Course Tests (EOCT). In order for the proposal to go into effect, seven state rules would have to be changed. Questions and comments from the panel were discussed. A new rule regarding the required number of math courses was passed. Effective for FY 08-09 students, Math 1 Supports and Math 2 Supports |
