Georgia Grant for High Cost Fund (GHCF)

The Individual with Disabilities Act (IDEA) 2004 gives States an option to set aside funding for the creation of a "Risk Pool" designated to assist local school districts in meeting the high cost needs of providing special education services to certain individual children with disabilities.

These funds will assist local school systems in covering the direct special education instructional costs of children with disabilities who meet the criteria established in IDEA 2004 and the system plan for GHCF. In FY10 approximately \$3,000,000 will be available for distribution to local systems through the Grant for High Cost Funds (GHFC).

- 1) A "High Need Child" is defined as a child who has been identified as eligible for special education and related services and has a current Individualized Education Program (IEP). The intensity, frequency and diversity of the special education needs of the child exceed the typical needs of a child with a disability.
- 2) IDEA 2004 requires the eligibility for reimbursement for a high needs student be at least three times the average per pupil expenditure as defined in Section 9101 of the Elementary and Secondary Education Act of 1965. In Georgia for FY10 direct costs must be in excess of \$27,000.

Annually, the GaDOE will begin accepting applications for the GHCF on October 1. The ending date for submission is April 1 of each fiscal year. The award letters for the GHFC expenditures in a school year will be issued by May 30. Additional information regarding the criteria and grant application will be posted on the special education webpage at the link, "Budget and Grant Applications." Read the instructions and established criteria carefully. LEAs should complete the application and provide documentation of expenses required for processing the GHCF application.

Statewide Assessments and Students with Disabilities: Upcoming Workshops

It is time for workshops and meetings that focus on the implementation of statewide assessments during the 2009-2010 school year. Two specific workshops may be of interest to special education directors and their designees.

The first series of workshops is the System Testing Coordinator Conferences. In each workshop, all statewide assessments will be discussed. There will be one face-to-face workshop and additional workshops will be provided and recorded via Elluminate. Therefore, special education directors can tune in and receive the latest information regarding all aspects of the specific tests within testing program. Accommodations are not scheduled to be discussed during these sessions, as a separate series of Elluminates will be conducted on this topic.

The second series of workshops is the Georgia Alternate Assessment (GAA) Fall Workshops. Conducted by personnel from the Division of Special Education Services, the Division of Assessment, and Questar, these workshops will focus on the logistics of the 2009-2010 administration of the GAA as well as training on aspects of fidelity, data documentation, and portfolio development and review that are targeted based upon information gathered during 2008-2009. Six half-day workshops will be held in various locations around the state. In addition, an Elluminate session will be held for those who are administering the test for the first time.

Each of the GAA Workshops is designed for system test coordinators, special education directors and a designee. BECAUSE there is a focus on further implementation of appropriate and effective practices around the developing of activities and materials, gathering of data and compiling, reviewing and submitting portfolios, as well as redelivery of this information to teachers in the local systems, please ensure that the designee attending these workshops is someone who can redeliver and support all teachers in the system as they administer the GAA.

Autism Regional Team Meetings

Thank you for helping to make our First Annual Autism Academy in Perry this summer a huge success. We trained over 200 teachers during the academy on a series of major topics pertaining to successfully teaching students with autism spectrum disorders.

The Divisions for Special Education Services and Supports are conducting Regional Autism Team Meetings this year in follow up to our Autism Academy. The regional meetings will be available at four regions in Georgia to include Bibb County, Pickens County, Dougherty County and Liberty County.

We are suggesting that two representatives from each school district attend one of the regional meetings. The teams may be the same staff who attended the Autism Academy such as a teacher and SLP who can assist with training for school systems. The regional team meetings will be conducted as consortia planned and facilitated by our division and will focus on building capacity for working with students with autism spectrum disorders. Dates and locations for the Regional Autism Team Meetings will be announced through the DL Update and directors will be notified of how to submit names of participants.

GCASE/GaDOE Special Education Leadership Development Academy

This will mark the sixth year that G-CASE and the GaDOE have offered the academy, which was previously known as the New Directors' Academy. The name has been changed from the New Special Education Directors' Academy to the Special Education Leadership Development Academy to reflect the academy's role in training and supporting new directors, directors with limited experience, and those preparing for key leadership positions in special education such as coordinators or assistant directors.

The purpose of the SELDA is to provide long-term, sustained professional learning for special education administrators to become change agents in their systems, ultimately impacting the practices of teachers and the educational performance of students. Over the course of the school year, the participants will meet for five full days of training:

The SELDA uses the most valuable resource in the state to support new administrators: veteran Directors of Special Education. The mentor directors and the protégés will work in pairs, small groups, and large groups to share and learn from each other. Each participant commits to participate in each training session, an e-mail group, and a total of 10 hours of collaboration outside of the training sessions with their mentor/protégé.

The academy focuses on two major strands of objectives: 1) school reform activities leading to improved performance for students with disabilities (e.g., improving leader and teacher practices), and 2) administrative leadership activities (e.g., budgets, data reports, FTE Counts). Ultimately, both sets of skills are needed to impact students' educational performance. Over the past several years, participants have reported that the academy has facilitated their growth not only in knowledge, but also in their leadership practices.

The registration fee for new directors/leaders is \$ 250, which includes professional membership in GAEL, CEC, GCASE, and CASE. Participants who are already have professional membership (all four organizations) will not pay a registration fee, nor will mentors. Professional Learning Units (PLUs) will be provided for participants who attend every session. New directors will also receive an email invitation this month.

Data Collection and Reporting Elluminates

The Divisions for Special Education Services and Supports are pleased to announce a monthly series of Elluminate Sessions focusing on data collection requirements for special education including Indicator 20 of the SPP/APR for the FY 10 school year. These sessions will also include activities designed to introduce participants to applications available to support the analysis of data aimed at improving student performance.

The interactive sessions are scheduled for the third Tuesday of each month at 8:30 a.m. Bonnie Dye is the session moderator. The Elluminates are intended for participants including special education directors, coordinators, instructional technology staff and/or administrators who are responsible for timely and accurate data reporting of student level data.

Specific topics will be discussed each month beginning with the basics of data collection and the types of data reporting required by the state department. Come join us for the live, interactive sessions.
