Additional IDEA Funds for Carryover

At the February State Board Meeting, reallocated additional IDEA funds to LEAs were approved. These funds must be used by the end of the current school year. Approximately \$24 per child was allocated, so please submit a budget amendment as soon as possible to access the additional funds. If the LEA was in the process of making an IDEA amendment, the funds will appear after the current amendment has been approved.

NOTE: When making an IDEA amendment, there will be an error message for CEIS. Go back into the grant, click on Program Information; then click on Exceptional Students, next click on CEIS. Put in the original status: NA, optional or required and then save. For some systems this item is not copying over to the amendment process.

ARRA Funds

Only 58% of the IDEA ARRA funds and 54% of the ARRA Preschool funds have been drawn down as of February 15th. Please review expected expenditures to ensure that all funds are obligated by June 30th and spent by September 30th. Remember to access ARRA grants by resetting the FY status bar in the upper right hand corner to FY10.

Occupational Therapist (OT)/Physical Therapist (PT) Contact Meeting Update

The first face to face OT/PT Contact Meeting was held February 15, 2011 at Griffin RESA in Griffin, Georgia. Approximately 80 therapists designated by their districts as the state contact, attended the meeting. The focus of the discussion was the new Frequently Asked Questions (FAQ) document and additional content that will be added to the Related Services section of the Special Education on-line Implementation Manual. Therapists were able to share information concerning a variety of topics that impact educationally relevant therapy in the school systems. The next meeting will be in May and each contact person will be sent the registration information.

As a reminder the OT/PT contact meeting is only for the district designated contact. We are encouraging Special Education Directors who have not submitted the information for their designee to do so as soon as possible. While Special Education Directors are welcome to attend the meetings we only need one therapist per district. Once every district has designated a representative, there could be more than 187 people attending. It is the Division's desire to have every district represented. The designated representative is responsible for sharing the information from the meetings and redelivering any training provided.

The Dispute Resolution Continuum: Mediation

A quick reminder about the five stages of the dispute resolution continuum from Feinberg et al. (2002):

<u>Stage</u>		Example of Options
I.	Prevention	Active stakeholder collaboration, training
II.	Disagreement	Local director, parent to parent assistance
III.	Conflict	Mediation
IV.	Procedural Safeguards	Formal Complaint
		Due Process Hearing Request
V.	Legal Review	Formal Hearing

This month the focus is upon mediation as a conflict resolution strategy. Beginning in 1997, Congress strongly emphasized mediation as a primary (although not exclusive) way to attempt to formally resolve conflicts in special education. Mediation is designed to:

- Afford the participants a structured opportunity to meet and discuss their concerns and to work collaboratively to create a mutually satisfactory agreement
- Empowers the participants to explore issues, make decisions, and design solutions
- Offers a voluntary process for mutual problem solving without assigning blame or determining fault
- Provides a confidential process to all participants
- Emphasizes communication and creative problem solving by providing a mediator to assist the participants in defining their problems, exploring their interests, and resolving their conflicts together
- Focuses on the future by describing what future interactions, plans, agreements, or behavior changes will occur.

State Rule 160-4-7-.12 DISPUTE RESOLUTION specifies the requirements for formal complaints, mediation, and due process hearings in Georgia. The mediation process is available upon request of either party to resolve disputes at any time. The rule provides that mediation shall be available and offered upon each receipt of a complaint or a due process hearing request. Further, the procedures shall ensure that the mediation process is:

- Voluntary on the part of the parties;
- Is not used to deny or delay a parent's right to a hearing on the parent's due process complaint, or to deny any other rights afforded under Part B of IDEA; and
- Is conducted by a qualified and impartial mediator who is trained in effective mediation techniques.

The GaDOE maintains a list of individuals who are qualified mediators and knowledgeable in laws and regulations relating to the provision of special education and related services. Mediators are selected on a rotational basis. You can access the procedures and form to request mediation using the following link:
