NOTES

- 1. Clarification on Data Type Indicator.
- Data Type Indicator '1' must have valid data in both the Discipline Incident and Discipline Action fields.
- Data Type Indicator '2' must have valid data in the Discipline Incident and Context/Location fields. Data for the Discipline Action code must be '00'.
- Data Type Indicator '3' must have valid data in the Discipline Action and Action Auxiliary fields. Data in the Discipline Incident and Context/Location fields must be '00'.
- Any records with a Data Type Indicator of '2' or '3' must be preceded by a record with a Data Type Indicator of '1' for the same Discipline Incident Number (ex. E001)
- 2. Non-reportable incidents or actions with reportable actions or incidents: for records where either the incident or the action is a reportable item and the other is not, please enter the non-reportable incident as '24 Other Incident' and if the action is non-reportable, please record it as '80 Other Action'.

For example:

- If a student is assigned to In School Suspension for repeated violations of a non-reported incident such as chewing gum in class, his/her record would have an Discipline Incident code of '24 Other Incident' and a Discipline Action code of '20 In School Suspension'.
- If a student was assigned an alternative action such as being assigned to remove graffiti from a wall in response to Vandalism, the Discipline Incident would be coded '20 Vandalism' and the Discipline Action would be coded '80 Other Action'.
- 3. The following table gives an overview of valid combinations for the reporting of data elements associated with discipline events.
