- Improves services to children and families




**GADOE** Response

- <u>Real-time access to student IEP data</u>
  - Access any IEP record, any time
  - Access by multiple teachers and administrators based on access rights
  - Availability of reports and indicator data
  - Integrated with the SLDS system
  - IEP available on incoming Georgia students



- <u>Reduced burden & expense on LEA</u>
  - Some reporting requirements automated
  - Inter-district transfers streamlined
  - State funded & supported



- State and Federal Reporting:
  - Timeline data
  - IEP annual tracking
  - Transition plans



- Better tools for managing IEPs
  - Built-in wizards simplify process
  - Provides support to teachers
  - State & IDEA compliant IEPs
  - Reports for tracking

- Access to current and draft IEPs








