- False. Services are only required if nondisabled peers receive services during short term removals.
- 2. False. It is assumed that when students are in ISS they continue to receive sped services and supports. In school suspension does not count for the 10 days as long as they have the opportunity to appropriately participate in the general curriculum, continue to receive the services specified on the child's IEP and continue to participate with nondisabled peers. ISS is not counted as suspension from compliance standpoint but for dispro ISS is counted.
- 3. True. FBA and BIPs are only required when it is has been determined that the behaviors that violated the code of conduct is a manifestation of the students disability. FBAs and BIPs should be considered when students are demonstrating frequent behavioral problems. if it is determined to be a manifestation of the student's disability, a functional behavioral assessment (FBA) and a behavioral intervention plan (BIP) must be developed, reviewed, and/or modified. If already completed, the FBA and BIP must be reviewed and revised as necessary.
- 4. True and False. If the student has special transportation identified on IEP and is suspended from the bus, he or she cannot access their special education services and supports. It is counted as OSS unless district makes provisions for alternate transportation. If a student does not have special transportation as in IEP service, being suspended off of the bus does not count as OSS.
- 5. False. The manifestation determination is made by parent, LEA, IEP team members. A parent can appeal the results of the manifestation determination.
- 6. False. It is not required to conduct a FBA prior to BIP. It is best practice to develop your BIP based on the results of your FBA. If the IEP team has adequate information to develop a Behavior Intervention Plan, a Functional Behavior Assessment may not be required. Although not required, best practice is to conduct an FBA prior to the development of a BIP.
- 7. False. Parents have to be immediately notified regarding changes of placement.
- 8. True. The FBA is considered to a component of a reevaluation and therefore a parent can request and IEE if they disagree with the reevaluation results.
- True. A manifestation determination is held whenever a decision is made to change the
 placement of a child with a disability because he or she has violated a code of student conduct.
- 10. False. If students are suspected of having a disability, even if they have not yet been found eligible for special education, they are protected under Discipline rule
- 11. False. The student has to remain in the IAES until the appeal is decided.
